This is the last Will and Testament of me Sarah Bass of Stamford in the County of Lincoln spinster ffirst I direct that my body may be interred in the Church Yard of the Parish Church of Saint George in Stamford near to the remains of my late father and mother and that my funeral may be conducted in a plain and neat manner I give and bequeath unto Jane the wife of Zacheus Pollard of Saint Martin Stamford Baron in the County of Northampton Carpenter the sum of five pounds and also all my linen pictures china glass and chimney ornaments with all my books (except those herein otherwise bequeathed)letters and papers I give and bequeath unto Edward Clarke late of No 126 ffleet Street in the City of London Cordwainer my two large silver table spoons marked J B and unto their son Charles a legacy of five pounds unto Mary Tyler of Stamford aforesaid spinster my six other silver tea spoons unto Mary Barber of Stamford aforesaid spinster my small linen press and Johnson's Dictionary and also a legacy of five pounds unto Sarah Reed of Stamford aforesaid spinster my small writing desk and also a legacy of five pounds unto Sarah Clarke of Stamford aforesaid spinster a legacy of ten pounds unto Mary the wife of Daniel Nickolls of Park Street Islington in the County of Middlesex Painter my silver sugar tongs and the Numbers of the Saturday and Church of England Times and unto the said Zacheus Pollard a legacy of ten pounds unto Jane the daughter of the said Zacheus Pollard the sum of five pounds I give and bequeath unto Jane the wife of William Reed of Stamford aforesaid Chief Constable my work table and a legacy of five pounds I give and bequeath unto Mary Ann the daughter of the said William Reed the sum of nineteen pounds and nineteen shillings and unto James the son of the said William Reed the sum of ten pounds I give and bequeath unto my servant Elizabeth Parker of Saint Martin Stamford Baron aforesaid the sum of five pounds and also one half part or

share of my wearing apparel I give and bequeath unto Mary the wife of Daniel Marshall of Stamford aforesaid Green Grocer all the rest and remainder of my household goods and also all the remaining half part or share of my wearing apparel and I do direct my Executor hereinafter named to pay the respective legacies and sums of money before mentioned to the respective parties entitled thereto within three months after my decease I also give unto the said Mary Marshall my watch i give and bequeath unto Sophia Eliza Baker Collinson the wife of the Reverend Henry King Collinson of Stannington Rectory in the County of Durham a ring left me by the late Mrs Roberts and also a legacy of three hundred pounds I give and bequeath unto Albinia Baker Tachwell of Stannington aforesaid spinster all my written cookery books and also a legacy of three hundred pounds and in case either of them the said Sophia Eliza Baker Collinson and Albinia Baker Tachwell shall happen to depart this life in my lifetime then my will is that the legacy or sum of three hundred pounds hereby given and bequeathed shall be paid by my executor hereinafter named unto the survivor of them the said Sophia Eliza Baker Collinson and Albinia Baker Tachwell and as to all the rest Residue and remainder of my money and securities for money stock in the public funds and personal estate of whatsoever kind and description the same may consist of (not hereinbefore disposed of) I give and bequeath the same unto the said William Reed to and for his absolute use and disposal And I do nominate and appoint the said William Reed sole Executor of this my Will hereby revoking all former and other wills by me heretofore made In Witness whereof I the said Sarah Bass the testatrix have to this my last will and testament (written on three sheets of paper) to each of the said sheets set my hand and to this last affixed my seal this twenty eighth day of January in the

year of our Lord one thousand eight hundred and forty seven _Sarah Bass
